TERMS AND CONDITIONS**

Prices: Prices are quoted in Canadian funds. Prices advertised are based on fixed cost at the time of printing. Costs are dependent on several factors. Should these cost increase, Camp Tournesol reserves the right to increase the price. Every effort will be made to advise our clients of the price increase at least 60 days in advance of your trip departure. If the increase is greater than 7%, the individual has the right to cancel the contract for the travel service and receive a full refund.

Payments: Payments must be received as per the fee schedule attached. Failure to remit instalments as defined will result in the cancellation of the student WITHOUT refund.

NSF policy: a \$40 service charge will apply to all returned cheques. Replacements for NSF must be in the form of certified cheque, money order or cash.

Cancellations: The \$350 deposit is non refundable at any time however can be transferred to another program for the same child. After January 16th 2012 it is also non transferable. 50% of the remainder cost is non transferable and non refundable after 90 days prior to departure. Following that time 100% of the total package price is non transferable and non refundable.

Rooming: Lodging configuration consists of tents of 3 to 4 campers of the same gender. Campers may be asked to share a tent with a counsellor of the same gender.

Fear of height, paddling and swimming ability: Some of the activities that your child will participate in may involve being at a higher height than usual as well as an ability to swim and paddle. Every child registering for this trip is aware of this requirement and will not refuse to participate in any of the activities because of a fear of height or fear of water.

Camp Tournesol responsibility: Camp Tournesol makes arrangements with guide services, attractions, restaurants and other independent parties to provide you with travel services. Camp Tournesol takes great care in selecting these suppliers, but does not have any control over them and thus cannot be responsible for their acts or omissions. Camp Tournesol is subject to conditions and liabilities imposed by these suppliers. If such services and accommodation cannot be supplied due to causes beyond our control, Camp Tournesol assumes no responsibility or liability other than Camp Tournesol makes the best efforts to supply other services and accommodation, which will be comparable to those originally booked. Camp Tournesol shall not be responsible for any loss, damage, illness, injury, inconvenience, loss of enjoyment, anxiety or fear arising from: a) the act, omission or negligence of any travel service or supplier whose product you purchase, b) theft, strike, lockout, mechanical failure, government restrictions, weather conditions or any other cause beyond control, c) your failure to provide your child with all the requisite documents, d) campers failure to follow schedules and/or instructions regarding hotels, bus, attractions and so forth, e) personal injuries or death, f) being excluded from participation of trip due to unpaid balances of monies owing.

Camp Tournesol reserves the right to make any changes of equal value before or during the tour for the comfort of our participants without prior notice. Camp Tournesol reserves the right to expel any member of the tour, at their discretion, before or during the tour should such person's presence be considered disruptive to the interest, comfort and safety of the other members. Persons dismissed from the group before or during the tour will be subject to the same cancellation policies previously outlined. Any member expelled from the tour will be sent home at the parent's expense. Camp Tournesol cannot assume responsibility for reprimands a member of the tour may receive from hotels, restaurants, attractions and bus companies.
